- 1. I declare that I have completed this form completely and truthfully. If there are any changes in, for example, records, telephone number or otherwise, I will immediately pass on these changes by email to info@boxing.cw
- 2. I agree to be on time at; the medical check, the weigh-in, promotional activities (photo/video shoots, interviews, press conferences, etc.) and the competition venue (at least one hour before the opening ceremony).
- 3. I agree to show the agreed weight on the scale at the weigh-in. I am aware that by not making the agreed weight, this may end up into a penalty and/or not participating in the competition.
- 4. I declare to be in a proper physical condition to participate in the sport of boxing, not to be medically suspended, and in the possession of a valid medical/ health insurance.
- 5. I confirm not to be pregnant (only in the case of women).
- 6. I confirm not to have epilepsy or any other type of faint, convulsion or black-out, not been knocked unconscious in the previous 3 months, no broken bones or cuts needing treatment in the previous 6 months, not have had any eye disorders or operations (including laser eye surgery).
- 7. I shall notify the organization immediately in case of cancellation due injury or family emergency and will provide appropriate documentation as proof.

- 8. I agree that CuraBox and/or the (event) organization retains all media rights, including broadcasting, recording, and promoting the event. I am aware and agree that I may be recorded and that the material may be used for promotional activities. CuraBox has no payment requirements regarding this.
- 9. I shall ensure that my conduct may not in any manner tarnish the reputation of the sport of boxing.
- 10. I shall in all instances, respect all rules and regulations set by CuraBox and the (event) organization, like; competition rules (see rules on page https://boxing.cw/documents/), anti-doping rules, and act accordingly.
- 11. I shall not collude or collaborate with any party by violating any rules of the sport.
- 12. I shall always conduct myself respectful to the organization, officials, and competitors.
- 13. I shall not criticize or attempt to explain calls or decisions made by any Boxing Competition Official.
- 14. I shall not in any circumstances, (in)directly, solicit, accept, or offer any form of remuneration or commission, nor any concealed benefit, service or gift of any nature that could be considered as a bribe or undue influence.
- 15. I shall not bet on any part of the boxing competition, bouts, or anything that would conclude a decision of a contest; nor shall I share inside information at any time and in any circumstance.
- 16. I must immediately upon receipt, report any approaches or offers, such as those described in 14 and 15.
- 17. I shall not enter into any form of harassment or abuse, be it physical, professional, or sexual, and cause or instigate any physical or mental injuries outside of the competition.
- 18. I shall not discriminate against anyone based on race, color, religion, gender, age, national origin, disability, or sexual orientation.
- 19. I shall not engage in disrespectful conduct of any sort including profanity, obscene gestures, and offensive remarks of a sexual or racial nature, trash-talking, taunting, boastful celebrations, or other actions that demean individuals or the sport.
- 20. I shall refrain from conduct that could cause serious damage to the sport, including in any case conduct punishable by law and conduct that is seen as socially improper.
- 21. I shall live up to high ideals of ethics and sportsmanship and always pursue victory with honor according to core principles: trustworthiness, respect, responsibility & fairness.
- 22. I shall honor the spirit and the letter of rules; avoid temptations to gain competitive advantage through improper gamesmanship techniques that violate the highest traditions of sportsmanship.
- 23. I shall not be under the influence of alcohol or drugs, while participating in any event, including all related meetings, weigh-in duties, etc.

I am fully aware, acknowledge and accept such dangers and risks and shall not hold CuraBox (Curaçao Boxing Association), representatives and/or the (event) organization, accountable for any and all damage suffered, including but not limited to, property damage, personal injury or death. Participation in any activity is done at my own risk. CuraBox, representatives and/or the (event) organization, cannot be held liable for personal injuries and accidents of any kind. I hereby waive now as then any right to bring a claim for damages against CuraBox, representatives and/or the (event) organization, whereby I could claim compensation for costs, damages and interest arising from any injury or injury sustained as a result of sports.

This limitation of liability clause is intended to be as broad and inclusive as permitted by Curacao law.
