

## CuraBox Code of Conduct for Coaches/Seconds

This code of conduct has been drawn up by CuraBox and constitutes a binding document for all coaches/seconds active during boxing bouts under the auspices of CuraBox. The goal is to ensure a safe, professional, and orderly sports environment. All provisions in this code of conduct must be strictly adhered to.

### 1. Number of coaches/seconds and position

- Only persons who have signed this form will be registered as coach/second and are authorized to stand in a boxer's corner.
- A maximum of three coaches/seconds are allowed during a bout.
- Only two coaches/seconds are allowed on the raised platform surrounding the ring. One of them may enter the ring during the break between rounds.
- If a coach/second enters the ring at any other time, the referee has the authority to stop the match and disqualify the boxer with whom the supporter is assigned.
- Coaches/seconds may only enter the ring at the referee's direction and not before or after the match, until the official results have been announced.
- Before the start of each round, all coaches/seconds must leave the ring and clear the area of chairs, towels, buckets, etc.
- During rounds, coaches/seconds must sit on chairs in the assigned corner outside the ring. It is not permitted to stand, walk or make contact with the ring, ropes or canvas.

### 2. Dress code

- Coaches/seconds must wear representative sportswear. Club or team attire is recommended.
- Suitable closed-toe footwear is required. Flip-flops or sandals are not permitted.
- Clothing and accessories with inappropriate, offensive, or prohibited expressions are not permitted. This includes political, religious, and racial symbols, propaganda, firearms, and substances on the WADA list of prohibited substances.

### 3. General standards of conduct

- Coaches/seconds must conduct themselves professionally and respectfully.
- Instructions must be given clearly, correctly, and respectfully.
- The use of foul language, insults, or inflammatory remarks is prohibited.
- Verbal or physical violence, threatening language, or intimidating behavior towards officials, opponents, athletes, or spectators is not permitted.
- It is prohibited to stand up during the match, encourage, or incite the spectators with words or gestures.
- Arguing with or shouting at officials is prohibited, as is showing dissatisfaction through physical actions such as throwing objects, kicking chairs or bottles, or other unsportsmanlike behavior.
- According to international rules, results are final and cannot be protested.

#### **4. Professional appearance**

- Coaches/seconds actively contribute to a professional and positive image of boxing.
- They are responsible for complying with the rules and contributing to the orderly conduct of the event.
- Each coach/second must carry a towel and can signal a boxer to retire by throwing in the towel (not during a referee count).
- The use of an ice pack, Enswell, skin protection gel (such as Vaseline or Cavilon), and clear water bottles is permitted.
- The administration of medications other than those approved for use is prohibited.
- The use of supplemental oxygen or an inhaler is strictly prohibited under any circumstances.

#### **5. Sanctions for Violations**

In case of violation of the code of conduct, the following sanctions may be imposed:

- First violation: Verbal warning.
- Second violation: Removal from the Field of Play (FOP).
- Third violation: Removal from the event site.

Depending on the severity and/or repetition of the violation, additional disciplinary measures may follow:

- Written warning.
- Temporary suspension of the coaching license (for example, 3 or 6 months).
- Permanent revocation of the coaching license.
- Temporary suspension from participation in CuraBox competitions.
- Exclusion from participation in all CuraBox competitions for a specified period.
